26a. The template for surface area used in the swabbing of films should be sanitized on both sides. Both analysts sanitized the top of the template, but not the bottom.

At the time of the evaluation, the analysts and their supervisor were informed by this LEO of the necessity to ensure that the template is fully sanitized on both sides before it contacts the film. On further reading of item 26a of the NCIMS 2400 form the requirement is that the surface be "sterile." Best practice would be that it goes straight from autoclaved storage to usage. Another option for clear film is a simple dark colored template sitting under the film, only in contact with the non-product contact side.
